The Town of Star Valley has been awarded [or submitted an application for] a federal Community Development Block Grant (#124-18) through the State of Arizona Department of Housing (ADOH) funded by the U.S. Department of Housing and Urban Development (HUD) for the purpose of Connection of Purchased Well to Town Water System. Accordingly, the Town is seeking to contract with a qualified project engineer, duly registered in the State of Arizona by the Arizona Board of Technical Registration, to provide the necessary engineering design to:

The Town of Star Valley intends to use the FY17 CDBG funds to develop two Town owned wells located at Sky Run Lane. Through this project, the two wells (referred to as Sky Run well 1 and Sky Run well 2) will be connected to the Milky Way well site holding tanks, located at 193 Venus Road. The 1,800 feet of mainline pipe required to connect the wells to the holding tanks will follow existing easements and rights-of-way (ROW) running along Sky Run Lane and Mayfield Canyon Road. The development of the Sky Run well 1 and Sky Run well2 will allow pumped ground water to be transported to holding tanks located at the Milky Way well site and distributed to water customers currently serviced by the Milky Way well. The Town will use a competitively procured engineer and construction company to connect the wells to the Low/Mod income service area of the town of Star Valley. The service area includes the previous Milky Way and Quail Valley (Rainbow Drive) Projects. Based on previous Income Survey, the service area is qualified as defined by the town's Water Superintendent. The Sky Run wells are in an identified elevation zone 2 which will provide water unrelated to previously developed wells in zone 3. The combined water production of Sky Run well 1 and Sky Run well 2 will provide reliable service from an unrelated zone. The wells are registered with the State of Arizona, are approximately 17 years old, and have an approximate production of 490 GPM as reported by the Town.

The successful respondent will be responsible for performing all project related necessary engineering services to develop all preliminary and final construction plans and specifications and bid documents, including but not limited to, engineering, surveying, documentation of existing conditions, permits, etc. Additionally, the engineer will provide interim and final inspections in order to ensure construction according to specifications.
