The public body shall provide the officer, appointee or employee with written notice of the executive session as is appropriate but not less than twenty-four hours for the officer, appointee or employee to determine whether the discussion or consideration should occur at a public meeting.

- A.R.S. § 38-431.03.A.2 Discussion or consideration of records exempt by law from public b. inspection, including the receipt and discussion of information or testimony that is specifically required to be maintained as confidential by state or federal law.
- A.R.S. § 38-431.03.A.3 Discussion or consultation for legal advice with the attorney or attorneys of the public body.
- A.R.S. § 38-431.03.A.4 Discussion or consultation with the attorneys of the public body in order to consider its position and instruct its attorneys regarding the public body's position regarding contracts that are the subject of negotiations, in pending or contemplated litigation or in settlement discussions conducted in order to avoid or resolve litigation.
