DISCUSSION ITEMS:

1. Discussion and possible action regarding attendance at the 2025 League of Arizona Cities and Towns Annual Conference.

Town Manager Grier said this was an opportunity for the council to decide if they should attend this year's conference and who would be attending. Council decided that the five attendees would be Mayor Davis, Vice Mayor McKinney, Council Member Armington, Council Member McDaniel and Council Member Highstreet.

A motion to authorize town staff to register to attend the 2025 League of Arizona Cities and Towns Annual Conference and that the council members' registration and accommodation expenses be paid by the Town was made by Council Member Armington and was seconded by Council Member Highstreet.

A roll call vote was taken:

Vice Mayor McKinney <u>Yes</u>, Council Member Armington <u>Yes</u>, Council Member Binney <u>No</u>, Council Member Dueker <u>Yes</u>, Council Member Highstreet <u>Yes</u>, Council Member McDaniel <u>Yes</u>, Mayor Davis <u>Yes</u>.

The motion was voted on and passed 6 - 1.

2. Discussion and possible action regarding backup power for the water system.

Town Manager Grier said he directed staff to research the rental of generators and Engineer Dale Miller was on the phone to provide information. Engineer Miller said it came down to three (3) options. One option was to lease the generators. The second option was to purchase the generators. The third option was neither. Mayor Davis opened the matter up for discussion. Vice Mayor McKinney indicated that he was shocked at the cost of leasing the generators. Engineer Miller agreed and did not recommend it as an option. Vice Mayor McKinney asked if we purchased the generators would there be enough time to get them for the 2025 fire season. Engineer Miller said they could do an accelerated RFP without advertising and have the bids in about one month. He also found there were generators in stock with one dealer. It was all contingent upon getting a favorable bid. If all went right they could get the generators installed and working in about two to three months from now. Council Member Binney expressed reservations against buying the generators and felt batteries are a proven technology. Council Member Dueker felt they should consider putting out an RFP. Town Manager Grier agreed they should expedite this project. Council Members Highstreet and McDaniel also agreed. Mayor Davis asked for a motion. A motion to authorize town staff to solicit bids to put in place emergency backup generators for the Town of Star Valley water system. Staff is authorized to approve the lowest reasonable bid under emergency procurement for these generators at an approximate cost of \$255,000 was made by Council Member Highstreet and was seconded by Council Member Armington. A roll call vote was taken:

The motion was voted on and passed 6 - 1.

3. Discussion and possible action regarding re-obligation of the remaining COVID-19 ARPA funds.

Town Manager Grier explained that the town had to use the COVID-19 ARPA funds or lose them and recommended the town re-obligate the funds from water line replacement to the purchase of generators. He said they could take a look at the budget to see if they could still do the water line replacement at the next work study meeting. Council Member McDaniel thought it was a great idea to re-obligate the funds. Mayor Davis asked for a motion.

A motion to direct staff to obligate the remainder of the ARPA funds in the amount of \$264,974 to go towards the generator project and any additional fund money that is necessary to complete said generator project was made by Council Member Highstreet and was seconded by Council Member Armington.

A roll call vote was taken:
